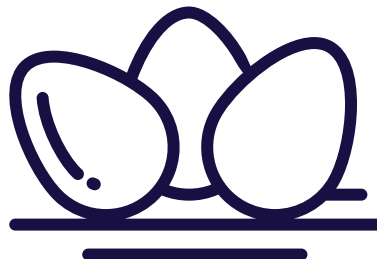

The Client, a major European institution, sought to develop a circular initiative that would repurpose poultry feathers.

Farrelly Mitchell worked as a leading member of a consortium charged with developing the methods and strategies needed to transform poultry feathers into valuable by-products.

In Europe 3.6 million tonnes of waste feathers are generated per year from the poultry sector. Around 25% is used for animal feed or fertilisers while the rest is disposed in landfills or incinerated.

This project focused on creating efficient processing techniques that would enable large-scale production of feather-based keratin. Farrelly Mitchell's work centred on overcoming technical, logistical, and market challenges inherent to this supply chain and included conducting numerous feasibility studies.

Our efforts enabled the creation of economically-viable processes and systems for producing and keratin-based products derived from poultry feathers, and ensured that these products could be successfully sold and distributed.

RICE, SOYBEAN, AND MAIZE PRODUCTION



The client on this project was a major multinational bank operating across Africa. They engaged Farrelly Mitchell to develop and deliver a comprehensive farm training program to 800 farmers specialising in rice, soybean, and maize production.

Our team conducted a series of capacity-building training sessions to equip farmers with technical skills and practices that would enhance production efficiency and output quality. This initiative included the development of a suitable strategy and methodology for effective knowledge transfer, sharing advanced production and postharvest techniques, and creating maize production materials. Training sessions were conducted both on-farm and in the classroom utilising hands-on trial sessions, field demonstrations, and open discussions, all of which encouraged active participation and ensured the practical application of learned techniques.

Following the training, a monitoring exercise revealed several positive outcomes. Farmers expanded their production areas, hired more farmhands, reduced time spent on tasks such as spraying herbicides and land preparation, increased their use of machinery and adopted more environmentally conscious practices regarding agrochemical use and disposal.

This initiative aimed to boost value-added textile manufacturing, provide financial and skill development resources, and promote export activities in Africa's underdeveloped textiles and apparel (T&A) industry.

To support this program, Farrelly Mitchell conducted an in-depth scoping review of the African T&A sector. 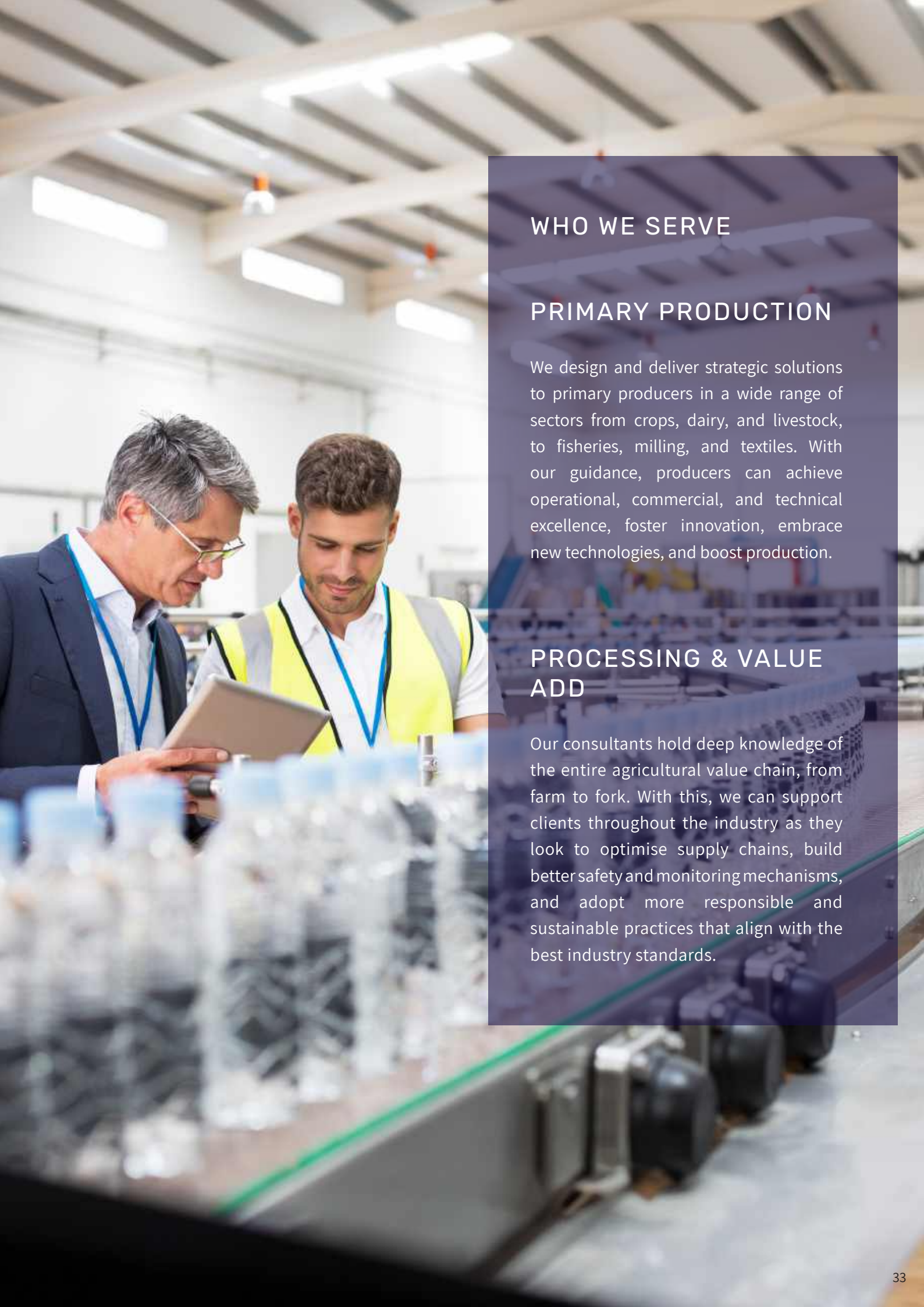
